# LOCAL ORDERS POLICY [DRAFT]

# **1.0 PURPOSE**

The Local Orders Policy assists Canterbury-Bankstown Council (Council) in enacting its regulatory responsibilities in the areas of animal management (including keeping of animals), Public Health and Environmental Protection by specifying the criteria that Council must take into consideration in determining whether or not to give an order under Section 124 of the *Local Government Act 1993*.

The Policy aims:

- To ensure the manner in which Council deals with the issuing of orders is consistent and fair, by issuing a clear set of formal criteria;
- To ensure Council's criteria and requirements for orders is readily accessible and understandable to the public;
- To meet community standards regarding health and safety of land and premises; and
- To create a system that is better able to effectively resolve disputes and conflicts as they arise.

# 2.0 SCOPE

The Local Orders Policy applies to all land in the Canterbury-Bankstown Local Government Area (LGA).

# **3.0 POLICY STATEMENT**

Council is committed to effectively managing its legislative obligations in respect to animal management, public health and environmental management in such a way as to facilitate a safe and healthy environment, to improve the amenity of the LGA, and ensure good governance practices.

Council's Local Orders Policy and subsequent Orders Schedule, outlines the circumstances that may warrant Council issuing an order for the following circumstances:

- Order 5 Compliance with standards and requirements
- Order 7 Fencing land
- Order 8 The identification of premises
- Order 9 Dangerous hole or waterhole
- Order 10 Unsightly articles or matter
- Order 11 Prevent and repair environmental damage
- Order 12 Control of surface water across land
- Order 15 Threatening or hazardous activities
- Order 16 Ceasing to use or evacuating premises
- Order 17 To leave or not enter premises



- Order 18 The keeping of animals
- Order 19 Use of tennis courts
- Order 20 Sanitary conditions in relation to food
- Order 21 Safe and healthy land and premises
- Order 22 Waste on land or premises
- Order 22A Remove Waste from land
- Order 23 Connection to water supply
- Order 24 Connection to sewerage system
- Order 25 Human waste storage facility on premises
- Order 27 Object or matter in a public place
- Order 28 Damage to a public place
- Order 29 Work or structure in a public place
- Order 30 Compliance with approvals

Note: Orders 1, 2, 3, 4, 6, 13, 14, & 26 either do not relate to Canterbury-Bankstown LGA or have been repealed by other legislation.

In exercising its function, Council will consider variations and exceptions to the criteria in the Policy, under certain circumstances and on a merit determination basis.

Amendments to the Policy and Local Orders Schedule may be made by Canterbury-Bankstown Council from time to time to reflect legislative changes.
