

Terms and Conditions of Entry

- 1. Information on how to enter and the prize form part of these conditions of entry.
- 2. The promoter of the Smart CBCity Competition (**Competition**) is Canterbury-Bankstown Council ("**CBCity**")(ABN 45 985 891 846) whose registered office is at 66-72 Rickard Road, BANKSTOWN NSW 2200.
- 3. Entry is only open to entrants (**Entrants**) from high schools in the Canterbury Bankstown Local Government Area (**Participating School**) who provide their email address and fully complete the submission as required on cb.city/smartcbcitycompetition.
- 4. Entrants who are immediate family members of employees of Canterbury Bankstown Council or Councillors may not enter the Prize Draw.
- 5. Partipication in the Competition is free. There is no entry free or purchase necessary to enter the Competition. Entrants however must supply their own equipment including softward and hardware reasonably required to participate in the Competition.
- 6. Entrants from participating schools must complete and submit an entry form by no later than 5.00pm on Friday 5 April 2019. Participating Schools can only submit a maximum of two entry forms for consideration in the Competition.
- 7. Entry forms must include an unlisted link to the video entry, hosted on YouTube and full access details if required. Video links must clearly identify the name of the Participating School and submitting teacher.
- 8. The rules of the Competition and the prize for the winner are as follows:
 - Participating Schools are responsible for choosing their top two entries for the Competition;
 - The challenge is to submit a 1-2 minute video to answer the following questions:
 - What does the future look like for you? Taking into account:
 - Technology;
 - Growing populations;
 - Changing demographics;



- Geo-political shifts in power;
- Scarcity of resources;
- Climate disruption; and
- Greater environmental pressures.
- o How should Council help build that future?
- Entries can be from individuals, groups of students or classes from the Participating School;
- Inappropriate images and videos including but not limited to those depicting nudity, violence, unsafe activities, substance abuse or misconduct will not be accepted;
- Entries will be judged on merit with the following considerations:
 - Use of design thinking to explain and solve a complex problem;
 - Creative solutions that consider the Smart Cities Roadmap which can be found at https://cb.city/smartcbcity
 - o Social utility of the submission
- Short-listed video entries will be uploaded by CBCity to its YouTube channel and embedded on its website/s at the discretion of the judges (and any other site as determined by CBCity). At least some members of the winning Entrant from the Participating School must be available for media interviews and photographs.
- CBCity reserves the right to republish videos and images of an Entrant's video entry in other formats and locations and use them for promotional purposes;
- Each entry must be an original work and must not have been previously published. It must not have been accepted for publication or under offer to any publisher or entered in another contest until the results of this Competition are announced;
- Submissions will not be returned and it is the responsibility of the Entrant to retain copies. All video entries become property of CBCity upon submission;
- Each entry must be accompanied by a valid entry form available from cb.city/smartcbcitycompetition listing the project title, along with the name, address and contact details fo the Partipating School, responsible teacher and a list of the participants. Entries submitted though a valid entry form will not be considered;
- Each video entry should include relevant credits;
 CBCity reserves the right to use the videos and images for promotional purposes after the Competition is completed;
- All responsibility for copyright clearance, parent/guardian permissions and content suitability remain with the Participating School or responsible adult. Participating Schools must not use



- music, images or any other content for which is does not have copyright ownership or written permission from the copy right owner to use; and
- The winning Entrant(s) will receive an Adventurer III Essentials 3D Printing Bundle to the retail value of \$1117.27 or similar subject to availability.
- 9. The prize is not refundable.
- 10. The prize is not transferable, exchangeable and cannot be taken for cash.
